This is an invitation to submit proposals for original exterior hand-painted murals at the new Anna Mae Cole Center and 2 Lamartine Street buildings in Jackson Square, Boston.

The Development team seeks proposals from professional artists for original 2D hand-painted murals at two new construction buildings located in the heart of Jackson Square, Jamaica Plain. These new long-term murals will be visible from popular community assets including the Jackson Square Playground and Southwest Corridor.

START SUBMISSION

OVERVIEW

The Community Builders (TCB), Jamaica Plain Neighborhood Development Corporation (JPNDC) and Urban Edge (UE) are three accomplished non-profit Boston-based development organizations with deep experience and success in developing vibrant, safe, affordable and mixed-income communities in the Jamaica Plain and Roxbury neighborhoods. In 2017, they were designated by the Boston Housing Authority to redevelop a portion of the Mildred Hailey campus, formerly known as the Bromley Heath Public Housing Development. The master plan includes replacing seven physically distressed buildings with seven new, modern residential buildings with new commercial and community spaces.

TCB is developing the first two buildings in the master plan located at future 2 and 6 Lamartine Street which will be adjacent to the Southwest Corridor and close to the Jackson Square MBTA station. The two buildings feature 223 affordable and moderate-income apartments, a new Anna Mae Cole Community Center, and an Innovation Center to support financial mobility, educational advancement, and career advancement in the community. The buildings will provide new apartments for current Mildred Hailey residents and welcome new households to the Jackson Square community. Between the two buildings will be the Anna Mae Cole Plaza, a new outdoor gathering space that connects the Mildred Hailey site with the Jackson Square Playground and Southwest Corridor. The two new buildings and their future murals seek to embody and amplify the vibrancy of the Mildred Hailey community.

PROGRAM THEMES AND GOALS

We are commissioning two new murals which will represent the core values and cultural richness of the Mildred Hailey residential community. We seek proposals from artists who have a strong artistic vision for these projects and whose work tells a compelling story of "home." The artwork should be culturally responsive, amplify the vibrancy of the neighborhood, and incorporate potential themes of unity, inclusion, or historical activism.

Community Engagement

Artists will work closely with the development team on designing and facilitating two in-person community engagement events as part of the design process. With input from Mildred Hailey residents and community partners, our goal is to capture the essence of this unique residential community while preserving your artistic vision and integrity for each mural.

Beauty and Sustainability

While beautifying the resident, visitor, and community member experience of the spaces, artists should choose materials and methods which consider the safety and well-being of the artists and community members during installation and for the life of the mural. A good submission will also consider artwork durability and maintenance requirements over time.

Connection to Place

This Request for Proposals aims to create opportunity for artists who have ties to Jackson Square, its neighboring communities, and its stories. We believe artists who have a meaningful connection to a place and its people can bring a unique perspective to long-term exterior artwork, illuminating not only the history, but also the aspirations of the community.

TWO OPPORTUNTIES

The development team seeks separate proposals for each commission opportunity listed below. Artists may submit a proposal for one or both commissions. The awarded artists will leverage the same community engagement events and onsite mural installation periods to ensure efficient use of onsite resources. If different artists are selected for the two murals, collaboration between both artist teams is welcome and encouraged.

Commission 1: Artist Installed Exterior Mural at the new Anna Mae Cole Center

Size: South façade: $15' \times 30' + \text{East façade: } 20' \times 30' = \text{Total } 1,050 \text{ sq. ft.}$

Budget range: estimated \$40,000 Installation period: September 2025

Desired Experience: Artists must have completed a minimum of five (5)

mural projects or projects of similar scale and complexity.

Commission 2: Artist Installed Exterior Mural at 6 Lamartine Street

Size: East façade: 9' x 20' = 180 sq. ft. Budget range: estimated \$12,000 Installation period: September 2025

Desired Experience: Artists must have completed a minimum of five (5) artwork projects that are relevant to this request for proposal. No specific

mural experience is necessary.

SUBMISSION MATERIALS (CONTINUED)

Budget Guidelines

Budgets must include all labor, materials, and equipment needed for final execution of your artwork. In addition to artist fees, please include items such as artist materials, equipment rental, insurance, refuse disposal, permits if applicable, and photo and/or video documentation of your process. Be sure to state the number of consecutive business days required for the onsite installation of the artwork. Please note the following:

- The substrate for both murals will be new fiber cement panel. It will be primed and ready to accept finish paint.
- The site will provide water and electrical service for the onsite installation of artwork. Details will be discussed with the operations team during the mural planning stage.
- The artist team members will be allowed access to bathroom facilities for the duration of onsite artwork installation. Bathrooms are limited to personal use only, and not for cleaning of artist materials and/or equipment. Itemized budgets should assume proper disposal of all materials per municipal and property regulations.
- Please assume typical work hours to be daylight hours. No additional lighting is planned for the installation of artwork.

SELECTION CRITERIA

The Mildred Hailey development team in partnership with Ivey Bueno Art Advisory will ensure a thoughtful and inclusive selection process. Will be evaluating proposals based on the following:

Artist Experience

This Request for Proposal aims to provide opportunities to artists at different levels of experience. We will evaluate submissions based on the strength of artistic vision, originality, creativity, freshness, and technical skill.

Submission Quality

A high-quality submission should be clear, thoughtful, and complete. It should include a sound budget, as well as a feasible plan for installation and maintenance of the artwork.

Community Engagement Experience

We want to work with artists who share our belief that community input can be a valuable part of the design process. Please describe creative ways you will engage the project site's community members.

Alignment with the Program Themes and Goals

We believe in the transformative power of art, and our aim is to commission artwork that will amplify the joy and welcoming spirit of this community. You may also refer to the City of Boston's Curatorial Vision for public art for helpful information.

A Commitment to Artists

Our team wishes to honor the time and effort put forth by all artists who respond to this RFP. All respondents will be notified by email in a timely manner of the selection results. Additionally, we are available for an optional 30-minute virtual meeting to exchange feedback on submission materials and/or the overall process with artists who were not selected for this opportunity.
